

## The Llewelyn Williams Postgraduate Studentship

*The Studentship is provided from the income of the Llewelyn Williams Trust Fund which was raised by friends, mainly in the legal profession, of the late W Llewelyn Williams KC MP (1867-1922) to perpetuate his memory, and transferred to the University of Wales for the founding of prizes or a scholarship as determined by the University.*

1. The annual income derived from the Llewelyn Williams Trust Fund shall be used to provide postgraduate studentships for research in Welsh History (which shall be interpreted to include Welsh laws and economic aspects of Welsh life). A studentship, the value of which will be the same as is paid to the holder of a State studentship<sup>1</sup>, will be awarded from time to time, as announced, provided there is a candidate of sufficient merit.
2. The award shall be made to a graduate in Arts or in Law of a Welsh University.
3. Candidates for the award should apply in writing to UWRET, on or before 1 June<sup>2</sup>. The student to whom the award is made shall inform UWRET before the commencement of the following session of the research work he/she proposes to undertake.
4. The studentship shall be tenable for one academic year from the date of the award and renewable for a second year<sup>3</sup>.
5. The condition of tenure shall be for the pursuance in a Welsh University or the Centre for Advanced Welsh and Celtic Studies (CAWCS) of a scheme of research but permission may be given by the UWRET on the recommendation of a Welsh university or CAWCS for the research to be pursued at some other place in the second year of tenure of the studentship, and in exceptional circumstances in the first year of tenure of the studentship.
6. The holder of the studentship shall, in each year of the tenure of the studentship, submit through his/her Institution a report of his/her work and progress.

The report in the first year of tenure shall be submitted to the Institution not later than 15 May. It shall include a statement as to the research proposed for the second year and the place at which it is proposed that the research shall be pursued.

The report in the first year of tenure shall be forwarded by the Institution to UWRET, together with the comments of the Institution upon it, not later than 15 June. The Institution shall state whether it recommends that the student's tenure of the studentship shall be continued for the second year, and, if so, the subject and place of research proposed for the student.

The report of the student at the end of his/her second year of tenure shall be submitted to the Institution not later than 1 September, and shall be forwarded to UWRET by the Institution, with its comments, not later than 1 October.

These regulations are formed on the basis of the original bequest. When making an award, Trustees may apply discretion and interpret the bequest for modern times.

Any reference in these regulations to 'Welsh Universities' (or a 'Welsh university') shall mean former accredited institutions of the University of Wales or other Universities registered in Wales.

1. The actual value of the award will be subject to available funds.
2. In some years the deadline may be extended.
3. Proportionate and subject to available funds
